Troop and Pack 127

For over 100 years, the Order of the Arrow (OA) has recognized Scouts and Scouters who best exemplify the Scout Oath and Law in their daily lives. This recognition provides encouragement for others to live these ideals as well. Arrowmen are known for maintaining camping traditions and spirit; promoting year-round and long-term resident camping and providing cheerful service to others. OA service, activities, adventures and training for youth and adults are models of quality leadership development and programming that enrich and help to extend Scouting to America's youth.

The Order of the Arrow has more than 160,000 active members located in lodges affiliated with over 270 BSA local councils. As of August 2018, there is now an OA lodge in every council across the United States.

Scouts are elected by their peers into the OA as long as they have met the requirements to be eligible for membership. **As of February 1, 2019**, unit elections are permitted in Scouts BSA, Venturing, and Sea Scout units. This is for both male and female scouts. The Order of the Arrow membership requirements are as follows:

- Be a registered member of the Boy Scouts of America.
- Have experienced 15 nights of camping while registered with a troop, crew, or ship within the two years immediately prior to the election. The 15 nights must include one, but no more than one, long-term camp consisting of at least five consecutive nights of overnight camping, approved and under the auspices and standards of the Boy Scouts of America. Only five nights of the long-term camp may be credited toward the 15-night camping requirement; the balance of the camping (10 nights) must be overnight, weekend, or other short-term camps of, at most, three nights each. Ship nights may be counted as camping for Sea Scouts.
- At the time of their election, youth must be under the age of 21, and hold one of the following ranks corresponding to the type unit in which they are being considered for election: Scouts BSA

First Class rank, the Venturing Discovery Award, or the Sea Scout Ordinary rank or higher, and following approval by the Scoutmaster, Crew Adviser or Sea Scout Skipper, be elected by the youth members of their unit.

 Adults (age 21 or older) who meet the camping requirements may be selected following nomination to and approval by the lodge adult selection committee.

There are three levels of membership (called honors) in the Order of the Arrow. The first is Ordeal which entails cheerful silent service with small amounts of food working on camp improvement projects.

After 6 months of service, an Ordeal member is eligible for the next level which is Brotherhood. This emphasizes the ideals of Scouting and when completed signifies full membership in the Order.

After two years of exceptional service as a Brotherhood member, and with the approval of the national Order of the Arrow committee, a Scout or Scouter may be recognized with the Vigil Honor for their distinguished contributions to their lodge, the Order of the Arrow, Scouting, or their Scout camp. This honor is bestowed by special selection and is limited to one person for every 50 members registered with the lodge each year.

Troop 127 has many OA members both scouts and scouters. This is all due to your continued support at both a Pack and Troop level which we appreciate. We wish you and your family a Happy Thanksgiving and we are thankful for Council 3880.

We had a total of 14 members and family work the Saturday shift. The new hours from 8:30am (or so) to noon have helped the decision making of some members to help out. Instead of a 4 to six hour shift 2 to 3 really seem more palatable for our busy Saturdays. Everybody has something to do be it yard work, family time or just plain taking a day off from the work of the week.

We served 53 clients in the three hours of service time the pantry was open. That number is up some from the previous few months. November and December usually are busy months with Holidays and the end of the spring and summer seasonal jobs. The volunteer crews will be split in December between the Food Pantry and Christmas tree lot. I'll really need the help the next few months.


